PREAMBLE

The Department of Law of Govt. Kaktiya Post Graduate College, Jagdalpur, Dist. Bastar (C.G.) was established in 1960. Govt. Kaktiya Post Graduate College, Jagdalpur is a prestigious college at Bastar division and it is lead college at Bastar district which is affiliated under Section 2(f) and 12(B) of the UGC Act, 1956; and recognized by Bar Council of India through letter no. BCI:D:659:2022 and by Shaheed Mahendra Karma Vishwavidyalaya, Bastar (C.G.) which is a Government University established under The Chhattisgarh Vishwavidyalaya (Sanshodhan) Act, 2008. Here, the college offers three years (6 Semesters) Degree Course (LL.B.) and two years (4 Semesters) Post Graduate Course (LL.M.) with specialization in **Crime and Tort** and also running a Research Centre in Law (PhD). So, this college is fulfilling its motto 'तेजस्विनावधीतमस्तु' by providing high quality Legal Education/ Socially relevant research and accessible to the students of the Bastar region.

The Chanakya National Law University, Patna, Bihar was established under the Bihar act no. of 2006. The University was included under section 2(f) of the UGC Act, 1956, with its headquarters at Patna. It is a "Public University" with an aspiration to provide high quality legal education accessible to everyone.

Whereas, Department of law, Govt. Kaktiya Post Graduate College, Jagdalpur desires to established academic collaboration with Institutions of excellence in law in the Country and Chanakya National Law University, Patna is one among such recognized institutions and seeks to promote the Institutional collaborations through this Memorandum of Understanding.

This collaborative research agreement is made of 27th March, 2025 ("Effective Date") for a further three years from the date of inception, between the Centre For Innovation Research and Facilitation, Chanakya National Law University, Patna and The Department of Law, Govt. Kaktiya P. G. College, Jagdalpur, Dist. Bastar, Chhattisgarh, India.

Whereas, the Centre for Innovation Research and Facilitation, Chanakya National Law University, Patna is engaged in teaching and research in the field of legal studies, support and Intellectual Property Rights protection up to UG, PG and PhD programme:

And,

Whereas, The Department of Law, Govt. Kaktiya P. G. College, Dharampura, Jagdalpur is engaged in Teaching, Research, Extension services and Scientific validation of Natural and Traditional Resources up to UG, PG and PhD programme in the field of Law/Biological Science.

And,

Whereas, both institutions are public institutions and are involved in non-commercial teaching, learning, research and service to society in their respective fields and areas, both institutions hereby intend to accept the following agreements for research and social services to common people, in their respective fields.

The objectives of the present MoU are:

1. To insure institutional cooperation in the field of Teaching research and IPR,
2. To investigate collaborative Biodiversity related works with IPR protection,
3. To do scientific validation of traditional knowledge with IPR protection,
4. To undertake and investigate other problem of the population related to legal support and health as per the need of society and mutual understanding of both parties in view of IPR protection.

To achieve the above objectives both parties propose the following agreement:

Article-1: Research Collaboration

- 1.1 Both institutions will work on objectives under teaching and research collaboration.
- 1.2 The Centre for Innovation Research and Facilitation, Chanakya National Law University, Patna will be responsible for support for IPR protection, patent filing, legal protection related to scientific exploration and commercial exploration for all mutual scientific studies.
- 1.3 The Department of Law, Govt. Kaktiya P. G. College, Jagdalpur, Chhattisgarh will be Legal and social support, scientific studies related to natural resources, interpretation of findings and required counselling to the affected population and all essential activities in the vicinity of institution regulated to biodiversity and IPR.
- 1.4 Further Legal/Scientific and Social problem may be undertaken as per need by the mutual understanding of both stakeholders based on their responsive expertise.

Article-2: Confidential Information

- 2.1 Both parties agree to maintain in confidence and do not disclose to any 3rd party, any confidential information of the other party required pursuant to this agreement. Each party agree to ensure that its employees have access to the other party's confidential information only on a need-to-know basis and that such employees are bound by obligations hereunder.



2.2 The party's obligations concerning non disclosure and non-use of confidential information received under this agreement shall continue for five years from the conclusion.

2.3 The information's related to the study will be mentions and conserved by both parties as per the rule of IPR, Biodiversity Act and ICMR, viz. disclosure of the identities of patients will be the subject matter of prior approval of concerned patients.

Article-3: Publications

3.1 The data generated by the study under this agreement may be used for Scientific publications or presentations involving all stakeholders with their due share of credits.

3.2 If any further study will be carried out by beyond two parties under such circumstances, the MoU signed with a third party will be binding for all stakeholders.

Article-4: Intellectual Property

4.1 The intellectual property generated by the study signed under this agreement will be combined for both parties.

4.2 If intellectual will be a contribution of any third party (As cited in Article 3.2) then the MoU signed with a third party will also be binding for all stakeholders.


Article-5: General

5.1 The expenditure involved in the study will be borne by a mutual understanding of stakeholder as per their feasibility.

5.2 Primarily the agreement will be valid for the next three years from the date of enforcement of MoU but as per unforeseen situations, both parties may reach on a consensus for premature termination of the agreement.

5.3 Any conflict of interest will be the subject matter of Jagdalpur and Patna jurisdiction only.




